## 35. ENVIRONMENTAL MATTERS/PUBLIC PARTICIPATION:

**Tree on walkway by Berkeley School** – This was coming from someone's garden on the pathways coming from Laidon Ave. The Clerk to contact Cheshire East Grounds Maintenance Dep.

**Rope Lane Bridge Fence** – As this had never been replaced, the Clerk to re-contact Highways and also mention the tree growing on the bridge.

**Road Surfaces** – there were potholes on Gresty Lane, Eastern Road and Rope Hall Lane. The Clerk to contact Highways.

**Caravan on Drive in Oakhurst Drive** – There was a clause in the deeds preventing this and as it was on private land was not a council matter. The Clerk would see if she could obtain any advice from the Planning Department.

### 36. POLICE MATTERS

PC Daniel Sambrook & PCSO Paula Davies gave a report of police related issues in Rope since the last meeting.

There had been few incidents of anti social behaviour and those occurring were mainly relating to congregating of youths in the Spa Car Park, which was a noise nuisance for the adjacent flats. There was some consideration relating to the siting of a security barrier.

There were several incidents of lose dogs.

There were incidents of water bombs and egg throwing but this had been dealt with by Shavington School.

The main problem in the parish was that of speeding. A Smiley SID had been used in Shavington & Rope and the Council owned one was now within the Police Division. Some discussion took place relating to 30mph bin stickers, which PCSO Paula Davies would enquire about.

Councillor AP mentioned an incident of a white van being parked on the verge in Oakfield Drive. PCSO PD was already dealing with this issue and was abut to give a warning to the owner and a subsequent fine if it continued.

The Chair mentioned the dangerous cycling by Shavington High School students. PCSO PD would mention this to the Deputy Head.

Councillor RD mentioned the building works at the farm across from the High School and requested that the police patrol include the building in their schedule.

There was some further Speedwatch training taking place and these sessions would now be more frequent for any further volunteers.
