

### Planning Application for up to 880 Houses in Rope

#### Up to 880 houses could be built on land opposite the medical centre and the high school.

An outline **planning application number 13/2874N** has been submitted by HIMOR for up to 880 houses. Their original master plan included the areas shown in yellow and had up to 1,089 houses. It is possible that future applications may follow if this one is successful

Rope Parish Council has no powers to prevent this application but will object to it. It will be decided by Cheshire East Borough Council initially and then finally by a Planning Inspector if there is an appeal.

Cheshire East has said that it will refuse applications for developments in areas such as this which were defined as Green Gap by the former Crewe and Nantwich Council. In the council's emerging plan this area would be protected as a Strategic Open Gap. The purpose of these gaps is to prevent the villages surrounding Crewe from merging with each other and ultimately Crewe merging with Nantwich.

Unfortunately the old Green Gap policy carries no weight if there is not a demonstrable 5 year housing supply. There is a dispute about this. The new plan is not complete, so the application is likely to go to appeal if it is refused.

As part of its consultation for the new plan Cheshire East put this site forward as a possible option. 97% of those that responded disagreed that this site should be developed.

It will strengthen the case against this application if it can be shown that there is strong opposition from the public. You can make your views known by commenting on the planning application. **Comments must be received by 28 August 2013.** If you have an internet connection then the easiest way is to do it on-line. If you visit the Parish Council website at the address shown below, you will find links direct to the planning application where you



will find the plans and more information.

### **Dog Fouling**

The Parish Council works with the Cheshire East community wardens and the PCSOs to reduce dog fouling.

Both the wardens and the PCSOs have powers to issue fixed penalties to anyone caught not cleaning up after their dog.

Sometimes there is very visible patrolling when the wardens are in uniform and walk round the parish

marking paths with chalk based spray paint, provided by the Parish Council. This reminds those who need it. that they should pick up after their dog and that the parish is patrolled.

On other occasions they patrol in plain clothes increasing the chance of catching offenders.

### **Crime Prevention**

We would like to make you aware that there have been incidents of breaks into sheds and garages in your area.

Our aim is not to scare you, but to raise your awareness, and to ask you to be extra vigilant.

To reduce the risk of being a victim of crime, follow these simple precautions:

Consider fitting an alarm to your garage or shed, most DIY stores stock battery operated alarms suitable for this purpose.

Always mark the property you keep within your garage or shed as this will help identification if they are stolen and recovered. Keep a list of

property with photographs if possible.

Make sure your garage or shed is fitted with a strong padlock, door hinges or other security measures such as a garage defender.

Make sure items kept inside the garage or shed are secure - large items can be padlocked together or you could sink a post into the floor of the garage and padlock any items to the post.

Always remember to lock your garage or shed after use.

Do not store large quantities of valuables in your garage and shed. Consider other forms of storage.

If your garage and shed is not in regular use, ensure that you visit it regularly to check for any signs of damage, or ask a neigbour or friend to keep an eye on it.

Keep property and fencing in good repair and ensure that foliage / trees etc are kept trimmed.

Check with your insurance company that you are covered for items stored in your garage or shed.

Report any suspicious activity to the police on 101 or anonymously via the Crimestoppers charity on 0800 555 111. Or you can speak to one of your local officers, please see below.
